Реферат	<p>A technology is proposed that makes it possible to determine the common information space of actors of social networks by identifying the semantic equivalence of collocations in texts. The technology includes a model of formal description of semantic and grammatical characteristics of collocates, identification of collocations, and determination of a semantic equivalence predicate of two-word collocations.</p> <p>Предложенная технология позволяет определять единое информационное пространство акторов социальных сетей за счет идентификации семантической эквивалентности коллокаций в текстах. Технология включает модель формального описания семантико-грамматических характеристик коллокатов, идентификацию коллокаций и определение предиката семантической эквивалентности двухсловных коллокаций.</p>
